

INCIDENT OVERVIEW

WebEOC Incident: 24-014 Severe Weather – Statewide – Apr0810 **Activation Level:** 4 Crisis Action Team (CAT)

INCIDENT OBJECTIVES

- 1. Ensure the safety of the public and first responders event
- 2. Clear and maintain roadways to facilitate safe transportation and provide timely information to drivers about road conditions and potential hazards
- 3. Monitor and respond to issues related to power outages and damaged infrastructure
- 4. Disseminate accurate and timely information about weather forecasts, warnings, and safety measures as well as educate the public on how to prepare for and respond to severe weather conditions, e.g. generator and carbon monoxide safety if power is out and generators are running and stay off the roads as they may be passible but dangerous hazards are present

WEATHER FORECAST

- Mild and decreasing clouds expected on Thursday
- It will be windy throughout the day...There is a WIND ADVISORY in effect from 7am to 6pm CDT for sustained winds of 15-25mph and gusts up to 40mph

- None No Wind Risk
- Limited Breezy conditions could blow around unsecured items and result in hazardous driving conditions on elevated roadways and bridges and for high-profile vehicles. Recreational boaters should exercise caution on inland lakes.
- Elevated Windy conditions could damage outdoor items and result in hazardous driving conditions for high-profile vehicles.
- Significant Very windy conditions could blow down trees and cause isolated power outages.
- Extreme Extremely windy conditions will damage numerous trees and cause widespread power outages
