STATE OF EMERGENCY

ST. MARTIN PARISH

WHEREAS, the imminent threat of flooding along the Mississippi River, Atchafalaya River, and related bodies of water has the potential to cause extensive damage and flooding in St. Martin Parish.

WHEREAS, the flooding has the potential to enter structures in the form of boat traffic wake;

WHEREAS, An “Emergency No Wake Order” is in effect for Lower St. Martin Parish when the electronic, fixed USGS Gauge, placed on the Bayou Milhomme Bridge reaches 2.5msl. Said order will remain in effect until the emergency order is rescinded.

WHEREAS, immediate emergency actions are required to minimize the effects of the flooding;

WHEREAS, the area involved is in need of emergency actions and support for the flooding;

THEREFORE, I, Pete Delcambre, President of the St. Martin Parish Government by the authority vested in me by the Parish Charter and the Louisiana Disaster Act of 1993, do hereby proclaim;
